STRENGTHENING STRATEGIC TIES BETWEEN US AND INDIA: ANALYZE THE CURRENT STATE OF US-INDIA RELATIONS AND EVALUATE THE EFFORTS MADE BY THE BIDEN ADMINISTRATION TO ENHANCE BILATERAL TIES. EXAMINE THE AREAS OF COOPERATION SUCH AS DEFENSE, TRADE, AND CLIMATE CHANGE.

Introduction:

Climate Change
